- Food – Your pet's food prebagged for Overnight Boarding Guests
- Vaccination Record – A COPY (not original) of your pets current shot record
- Parasite Free – Make sure your pet's FLEA/TICK program is current
  - Optional: Your pet's bed/blanket. Make sure all items are labeled, washable, and maybe expendable.

Dog(s) Name \_\_\_\_\_ will be a guest at the Hounds To Horses premises, where he/she will be treated as a member of our family! The dog's owner will supply all food, meds, beds, and any other items required for the duration of the stay.

The parties herein agree as follows:

**(Initial)** \_\_\_\_\_ **Waiver of Liability:** Hounds To Horses agrees to provide the services stated above in this contract in a reliable, caring and trustworthy manner. In consideration of these services and as an express condition thereof, I waive and release any right I, my heirs, guardians, legal representatives and assigns many have or require to make a claim against, sue, attach the property of or prosecute Hounds To Horses or any of its owners, agents, employees for monetary damages caused by injury to my dog or damage to the property of my dog or myself arising from my dogs participation in the program and use of the facilities and property of Hounds To Horses, whether or not the injury or damage results from the negligence or other action, except intentional acts, or other releasees. This Owner's obligation is in effect so long as this contract is in effect and all fees are paid in full.

- I understand that Hounds To Horses is not responsible for any pre-existing or medical conditions pertaining to my pet(s), and that I have informed them on my pet's medical history.
- I understand that I am to provide all food for my pet(s) during the stay, and that they are not responsible for the loss or damage of any belongings such as bedding.
- I understand that if my pet enters with fleas or ticks that Hounds To Horses will have my dog(s) bathed professionally and treated at the owner's expense.
- I understand that even though Hounds To Horses requires that every dog be vaccinated with the Bordetella vaccine, the vaccine does not protect your dog from every new strain of the virus.
- I understand that the staff at Hounds To Horses are not vets or trainers. I certify that my dog(s) is non-aggressive and is not toy protective. Furthermore, I certify that my dog(s) have not ever harmed or shown any aggressive or threatening behavior towards any person or any other dog(s).
- I understand that my dog(s) will be a guest inside a home and I certify my dog(s) have perfect house manners. This includes but not limited no inside "marking the furniture", jumping child gates, digging, climb fences, chewing furniture and/or other items, eating socks or other random clothing, or bark/whine continually.
- While I understand that my dog may be supervised much of the time, I accept all responsibility for the fact that my dog may attempt to escape, and (while unlikely) may succeed.
- I understand that in the event that my pet bites or injures another pet or person, I as the owner assume all legal and financial responsibilities.
- I understand that the Hounds To Horses premises is zoned "rural" and there may be snakes, bees or other wildlife that could injure my dog(s).

## **Care Contract – Dog Boarding & Daycare**

- In the event of natural disaster including fire, Hounds To Horses is entrusted to use best judgment in caring for my dog(s), and they will be held harmless for consequences related to such decisions.
- All dogs over 7 months of age must be spayed or neutered in order to participate in a group play.
- I understand that it is up to the discretion of Hounds To Horses as to whether my dog(s) may participate in a group activity. I also understand that if my dog(s) is deemed misbehaving on ANY level that he or she shall be removed from the group, which may include kennel time.
- I understand that dogs may play “ruff”. I agree to not hold Hounds To Horses responsible for any injuries to my dog(s) due to play while in a group activity or any other time.
- We occasionally share photo updates of guest dogs and resident dogs on our website and other public social media places. I agree that Hounds To Horses may, at its sole discretion, publish these photos on their website and across social media including Facebook, and similar sites.

**(Initial)** \_\_\_\_\_ **Assumption of Risk:** I am aware that when dogs play in a group they run, jump, wrestle, and at times dogs get tired of each other. Since my dog will be a part of this group living program, I realize that at some point in time an injury may likely occur. I understand that there is a possibility that my dog(s) may be bitten, engage in rough play with another dog, or may be injured in some manner. With knowledge of the dangers involved, I voluntarily ask that my dog be allowed to participate in the group program. I accept any and all risks arising from participation in the program and the use of the facility, and accept all responsibility for his/her vet bills and/or any insurance deductibles. **I agree to reimburse Hounds To Horses for the \$100 deductible for any liability insurance claim filed involving my dog(s).**

This contract is a full and complete instrument. No other warranties expressed or implied are valid unless stipulated above. I am aware the agreement includes a waiver of liability, an assumption of risk and an agreement by me to indemnify any of the releases, and I sign it of my own free will. I have read this Boarding Contract AND the Boarding Requirement for accuracy and understand the contents of these forms.
